

# BESPOKE WINE JOURNEYS

## *Founding Traveler Agreement*

---

This Founding Traveler Agreement (the "Agreement") is entered into between **Bespoke Wine Journeys** ("Company"), operated by Molly Montgomery, and the individual identified below ("Founding Traveler"). By submitting a \$500 Founding Traveler Hold, the Traveler acknowledges and agrees to the following terms.

---

### 1. NATURE OF THE HOLD

The \$500 Founding Traveler Hold is a refundable reservation deposit that secures the Traveler's priority placement for the inaugural Bespoke Wine Journeys experience to the Republic of Georgia (the "Journey"). This hold is not a final booking and does not guarantee a specific departure date. It represents the Traveler's intent to participate and is fully credited toward the total Journey cost upon enrollment.

### 2. FOUNDING TRAVELER BENEFITS

By placing a hold, the Founding Traveler receives:

- Founding Traveler pricing **locked in permanently** — price will never increase for this cohort
  - Priority enrollment access before the Journey is opened to the public
  - Personal welcome call with Sommelier Molly Montgomery
  - Input on Journey timing and key preferences during planning
  - Founding Traveler recognition on all future Bespoke Wine Journeys
  - Lifetime Founder's Rate: **10% off** the first Journey, plus a permanent **5% discount** on all future trips

### 3. REFUND POLICY

The \$500 Founding Traveler Hold is **fully refundable** under the following conditions:

- The Traveler requests a refund within **60 days** of the original payment date, for any reason
  - Bespoke Wine Journeys cancels the Journey before a final itinerary is confirmed
  - The Traveler cannot accommodate the final confirmed departure dates and declines to transfer

#### **4. TRANSFERABILITY**

This hold is fully transferable to another individual at any time prior to final enrollment. The Traveler must notify Bespoke Wine Journeys in writing with the name and contact information of the replacement traveler. Transfer of the hold does not extend the original 60-day refund window.

---

#### **5. JOURNEY DETAILS & FINAL BOOKING**

Full itinerary, confirmed departure dates, and final per-person pricing for the Georgia Journey will be shared with all Founding Travelers prior to public release. No further financial commitment is required until the Traveler formally enrolls. Final enrollment will require a separate, written booking agreement.

##### **Anticipated Journey details at time of this Agreement:**

- Destination: Republic of Georgia (Tbilisi & Kakheti Wine Region)
- Duration: Approximately 8 days / 7 nights
- Group Size: 8–12 travelers (intentionally intimate)
- Anticipated Departure: **Fall 2027**
- Estimated Investment: Pricing to be confirmed and shared with Founding Travelers first

All details above are subject to change. Founding Travelers will be notified of any material changes before being asked to make a final booking decision.

#### **6. LIMITATION OF LIABILITY**

Bespoke Wine Journeys is not liable for any indirect, incidental, or consequential damages arising from participation in the Founding Traveler program. The Company's maximum liability is limited to the amount of the \$500 hold paid. This Agreement does not constitute a guarantee of travel and is subject to applicable laws and regulations.

**7. GOVERNING LAW**

This Agreement is governed by the laws of the State of Colorado. Any disputes arising from this Agreement shall be resolved through good-faith negotiation or, if necessary, in the courts of Colorado.

**8. ENTIRE AGREEMENT**

This Agreement constitutes the entire understanding between the parties regarding the Founding Traveler Hold and supersedes any prior verbal or written communications on the subject. It may be amended only in writing signed by both parties.
